Verification-Only Public Surface: This document is intentionally sanitized. It provides governance and verification information sufficient for initial compliance review without exposing sensitive operational details.

Evidence-First Definition: Any reference to 'delivered' means only POD-indexed delivery recorded in the evidence register at a controlled point. HHSAC does not claim patient-level delivery or end-user receipt.

Compliance-by-Design: HHSAC does not facilitate evasion of laws, sanctions, or controls. Ambiguity triggers EX/HOLD until resolved through documented escalation.

Purpose

This statement defines what HHSAC's Tier-1 Verification Surface includes and excludes. It prevents misinterpretation and establishes clear boundaries for compliance review.

Included in Tier-1

- Governance controls and decision gates (roles, segregation of duties, Two-Key sign-off logic).
- Evidence definitions and verification framing (POD-indexed delivery definition).
- Tiered disclosure model and Tier-2 request pathway (without operational detail).
- Document Registry entries: Doc IDs, versions, dates, classification, status, and SHA-256 checksums.
- Official contact channels for verification and escalation.

Excluded from Tier-1

- Operational details: routes, depots, capacities, schedules, local operators, or site identifiers.
- Counterparty identities and any sensitive procurement or logistics details.
- Payment instructions, bank details, settlement terms, and transaction-level financial information.
- Patient or end-user delivery, recipient lists, clinical outcomes, or medical claims.

Definitions (Bounded)

- **Delivered:** only POD-indexed delivery recorded in the evidence register at a controlled handover point.
- **Verified:** a claim whose evidence satisfies Gate 1 and has required approvals; unresolved items remain HOLD.
- **Tier-2:** controlled disclosure under NDA for authorized Prime/Bank/Regulators and permitted reviewers.

Compliance and Anti-Evasion Boundary

- HHSAC does not facilitate circumvention of laws, sanctions, export controls, or regulatory constraints.
- Requests that appear to seek evasion, concealment, or operational exploitation are refused and escalated.
- Ambiguity triggers EX/HOLD until clarified through the Risk & Compliance Committee pathway.

How to Request Tier-2 (Controlled) Access

- Submit a Tier-2 request to the Program Office stating purpose, scope, and authorized reviewer identity.

- Execute the mutual NDA template (HHSAC-NDA-001) or an approved equivalent.
- Await boundary check and approval; all disclosures are logged and minimized.
